Anti-Crisis (COVID-19) Solution

<u>Canada Emergency Wage Subsidy</u> Eligibility Criteria

Individuals, partnerships, private corporations and Canadian non-profits and charities who are experiencing a 30% or more (15% or more in March 2019) decline in revenues due to the COVID crisis. Revenues will be compared monthly for March, April, and May 2020 for the same time in 2019, or to the average of January and February 2020 revenue. Employers must attest you are doing everything you can to meet the 25% amount.

Amount

75% of wage subsidies up to \$847 per week per employee

Timing

Payments will be made within 6 weeks

How to Apply?

Applicants need to re-apply monthly. Application forms will be available on CRA website, **My <u>Business Account</u>** section.

Work Share Agreement

The program allows you to reduce employee working hours and remuneration by up to 50%, while the Employment Insurance pays a portion of the balance. The work share may be in place for up to 76 weeks.

Business Credit Availability Program (BCAP) Loan

It is a credit facility that will be provided by the financial institutions and crown corporations to the creditworthy Canadian companies. It is an interest-based loan focused on maintaining your cash flow. The maximum amount of loan is \$6.25 million per applicant (of which up to \$5 million is provided by the crown corporation) with flexible terms and payment postponements for up to 6 months.

Business Credit Availability Program (BCAP) Guarantee

It is a guarantee on your operating line of credit or term loan of up to \$6.25 million. The program is offered by the traditional financial institution and credit unions in conjunction with one of the crown corporations.



Canada Emergency Business Account

It will provide interest-free loans of up to \$40,000 to small businesses and not-for-profits, to help cover their operating costs during a period where their revenues have been temporarily reduced. The loan will be provided by the traditional financial institutions in cooperation with the crown corporations. To qualify, these organizations will need to demonstrate they paid between \$20,000 to \$1 million in total payroll in 2019. Repaying the balance of the loan on or before Dec. 31, 2022, will result in loan forgiveness of 25% (up to \$10,000).

Canada Emergency Commercial Rent Assistance (CECRA)

The program will seek to provide loans, including forgivable loans, to commercial property owners who in turn will lower or forgo the rent of small businesses for the months of April (retroactive), May, and June. Implementation of the program will require a partnership between the federal government and provincial and territorial governments, which are responsible for property owner-tenant relationships. More details to follow.

<u>Regional Opportunities Investment Tax Credit in Ontario</u> Eligibility Criteria

Canadian-controlled private corporation that makes qualifying investments that become available for use on or after March 25, 2020, in specified regions of Ontario. The tax credit would be available for expenditures in excess of \$50,000 and up to a limit of \$500,000. The tax credit would be available only in Northern Ontario and large parts of Southwestern and Eastern Ontario with the exception of Greater Toronto and Greater Ottawa areas.

Eligible Investments (Expenses)

Constructing, renovating or acquiring eligible commercial, industrial and certain farm buildings.

Amount

10% of eligible expenses reduce corporate income tax.

Timing

To be confirmed.

How to Apply

To be confirmed. Apply for tax credits at the end of your fiscal year.

Make Products or Develop Technologies to Fight COVID-19

- Government of Canada <u>call for proposals</u>
- Ontario Government <u>call for proposals</u>
- Advanced Manufacturing Supercluster <u>call for proposals</u>. The Supercluster provides up to 100% of the eligible cost to
 - support companies looking to develop and manufacture new therapeutics, equipment and products essential for COVID-19 response;
 - support manufacturers who currently produce essential equipment and products increase product output; and,
 - support manufacturers transitioning from the production of existing products to products essential for COVID-19 response.



Software Programs

Digital Main Street

Through the \$57-million contribution to the Digital Main Street platform, businesses will be able to take advantage of three new programs to support their digital transformation:

• **shopHERE** powered by Google will leverage Ontario's strengths by hiring highly skilled and trained students to build and support the launch of online stores for businesses that previously did not have the capacity to do so themselves. The core goal will be to help small businesses compete and grow, in a world that is increasingly online, and help them recover as quickly as possible following COVID-19.

Eligibility Criteria:

- Registered business, or a registered non-profit organization.
- Has a commercial location or is home-based.
- Has fewer than ten employees or fewer than 25 employees if a restaurant or bar.
- Not a corporate chain or franchise.
- Or must be an artist.
- **Digital Main Street Grant** will help main street small businesses be digitally more effective. Through a \$2,500 grant administered by the Ontario BIA Association, small businesses will be able to adopt new technologies and embrace digital marketing. Municipalities, Chambers of Commerce, and Business Improvement Areas (BIAs) can apply for a Digital Service Squad grant, which will allow them to establish teams to provide personalized, one-on-one support.
- **Future-Proofing Main Street** will provide specialized and in-depth digital transformation services and support that helps existing main-street firms adapt to changes in their sector and thrive in the new economy. By leveraging teams of digital marketing professionals and talented students, these firms will be able to create new online business models, develop and implement digital and e-commerce marketing strategies, and maximize digital tools, platforms and content.

Purchase or Upgrade of Equipment, Productivity Improvement

Canadian Manufacturers and Exporters (CME) Technology Assessments Program

Eligibility Criteria

- Must be a manufacturer based in Southern Ontario per the census map (Refer to Southern Ontario Service Area).
- Must be an incorporated business (federally or provincially) for 2 years or more continuously.
- Must demonstrate financial stability.
- Must have greater than 15 and fewer than 500 FTE employees maximum in Southern Ontario.
- Companies are not required to be a member of CME to be eligible.
- Not receiving other contributions toward the activities contained in the funding application from other government funded programs, including but not limited to: University or College Funding programs, Export Funding programs, Other related government funding programs.

Applications will be evaluated based on their ability to meet the following criteria:

- Technology improvements that aim to improve and modernize the manufacturing process, lead to increased productivity and competitiveness.
- New additions that contribute to the economic and environmental benefits to Ontario, including benefits expected from the project and interactions with other segments of the Ontario economy.
- Commitment to develop export markets, or be part of the value supply chain, or potential to become a strong global player on a regional or global basis.
- Creation of long-term employment and high-value jobs.

Eligible Cost

- Consulting fees (including travel) are eligible.
- Entertainment and meals are not eligible costs.
- All receipts for travel must be submitted with final claim. Any receipts that are not included will be removed from eligible costs.
- CME reserves the right to remove any unreasonable costs.

Amount

100% of eligible costs up to a maximum of \$25,000



Deadline

This program ends on March 31, 2022. We continue to accept applications for assessments until December 31, 2021 with a completion date of no later than January 31, 2022.

Business Scale-up and Productivity Eligibility Criteria

- Innovative and globally-oriented businesses seeking to accelerate their growth.
- High-potential firms (including accelerator graduates) that are commercializing innovative products, technologies and processes.
- Firms with scale-up potential looking to improve productivity through the adaptation/adoption of highly innovative, first-of-its-kind technologies with the goal of global competitiveness and market expansion.
- Entrepreneurs and businesses in rural areas looking to grow, commercialize and improve productivity.

Eligible Cost

- Assist high-growth firms to scale up and expand.
- Support technology demonstration and the commercialization of new technologies.
- Encourage the early adoption or adaptation of leading-edge technologies and processes to improve productivity.
- Increase businesses' capacity to grow through market diversification and entry into global markets.
- Foster innovation, technology adoption and digital connectivity in rural areas.
- Leveraging risk capital to accelerate the commercialization of products and services geared towards market diversification and growth.
- Automating and digitizing processes, and related skills development, to improve productivity and increase business capacity and competitiveness.
- The minimum project budget must be \$1.5 million

Amount

No-interest, repayable contributions from \$500,000 up to \$10 million per project.

Ontario Automotive Modernization Program Eligibility Criteria

• Small- and medium-sized Ontario-based enterprises (firms with fewer than 500 employees globally AND global revenues of less than \$1 billion) with a Business Number (BN).



- Larger companies are eligible; however, they must partner with at least one Ontario-based small- or medium-sized enterprise.
- Must be in the automotive supply chain to original equipment manufacturers.
- At least 50 per cent of the company's total sales revenue must come from the automotive supply sector.
- Must be a for-profit business (legal entity) registered to carry out business in Ontario.
- Must have a manufacturing location in Ontario by the time the project starts.
- Must have a minimum of two (2) years of financial statements.
- Must be in substantial compliance with all applicable laws.
- Must be free and clear of any fees, levies, charges or taxes owed to Her Majesty the Queen in right of Ontario or any of her agencies.
- Must be in compliance with the Accessibility for Ontarians with Disabilities Act, 2005.

Eligible Cost

- Salaries and benefits: Incremental salary and benefits for employees of the company working on the project activities, to a maximum specified in the funding agreement with the Ministry (position and employment status must be specified).
- Capital Costs:
 - \circ $\;$ Hardware and software implementation, installation, and setup costs.
 - Cost of direct materials, necessary for specifically identified activities and measured as having been used for, the completion of the project
 - Materials used for configuring, testing production processes, systems, and training employees.
- Training Costs:
 - Cost involved in providing personnel with training and/or development in novel techniques required for the project for their role(s).
 - Sub-contractor and consultant fees (must be associated with LEAN Mentorship).
- Travel and Living: Travel costs are explicitly project related, represent the most economical option (economy fare, and standard hotel room).

Amount

50% of eligible costs up to a maximum of \$100,000

Deadline

Friday, October 18, 2019.

Eastern Ontario Development Fund (EODF) Eligibility Criteria

The fund supports projects and investments to businesses, municipalities and not-for-profit organizations for economic development in eastern Ontario. Eastern Ontario includes the following 15 geographic areas: Stormont, Dundas and Glengarry; Prescott Russell; Leeds and Grenville; Valley Heartland; 1000 Islands; Frontenac; Prince Edward; Lennox and Addington; Muskoka; North & Central Hastings and South Algonquin; Trenval; Haliburton; South Lake; Northumberland; Ottawa; Peterborough; Kawartha Lakes; Lanark; and Renfrew.

Business Projects Eligibility

To be eligible, businesses need to:

- Invest at least \$500,000 in their project (or \$200,000 if you are in rural Ontario)
- Employ at least 10 people (or 5 if you are in rural Ontario)
- Commit to creating at least 5 new jobs (or 30% increase for companies with fewer than 15 employees)
- Be able to provide 3 years of operations/financial statements
- Be located in, or plan to locate in, a community in eastern Ontario

Community Economic Development Projects Eligibility

To be eligible, projects need to:

- Be led by municipalities, economic development organizations (including sector groups) or consortia
- Focus on economic and business development and job creation in the community or region by investing in infrastructure or implementing strategies to advance regional economic development priorities
- Lead to measurable outcomes including private sector investment, growth and job creation
- Invest more than \$100,000
- Have private sector support
- Be used for activities that are new to the organization

Eligible Cost

- Create jobs and build talent
- Attract and encourage private sector investment
- Business growth and broad positive economic impacts
- Innovation, collaboration and cluster development



Types of support

Business Projects

Funding amount

Up to 15% of eligible project costs.

Loans

Up to 15% funding to a maximum of \$5M, interest free during the project period (up to 4 years). If you achieve your investment and job targets, up to 30% of the loan (to a maximum of \$500,000) may be forgiven.

Grants

Grants are available only for specific circumstances, up to 15% to a maximum:

- Of \$500,000 if your company has fewer than 100 employees and is based in rural Ontario (population of your community is less than 100,000 or population density is less than 100 people per square kilometre)
- Of \$1,500,000 for strategic projects that are foreign direct investments or from companies competing against other jurisdictions

Community economic development projects

Funding amount

Up to 50% of eligible project costs for a maximum grant of up to \$1.5 million.

Restrictions

You are not allowed to combine (or "stack") Eastern Ontario Development funding with other provincial programs.

Deadline

Eligibility checklists can be submitted at any time.

There are four application intake periods per year for full applications. Applicants will be notified of decisions within 60 business days of the application deadline.

1) Application Period One:

Intake will begin December 2, 2019 with a deadline on January 20, 2020. Last day to notify applicants April 16, 2020.

2) Application Period Two:

Intake will begin March 5, 2020 with a deadline on April 20, 2020. Last day to notify applicants July 15, 2020.

3) Application Period Three:

Intake will begin June 5, 2020 with a deadline on July 20, 2020. Last day to notify applicants October 15, 2020.

4) Application Period Four:

Intake will begin September 3, 2020 with a deadline on October 19, 2020. Last day to notify applicants January 15, 2021.

- Labour Productivity Plans Eligible cost: 50%, up to a maximum of \$25,000
- Marketing Plans Eligible cost: 35%, up to a maximum of \$25,000
- Business Plans Eligible cost: 35%, up to a maximum of \$15,000
- Business Assessment Eligible cost: 50%, up to a maximum of \$15,000
- Education, Training, Assessment, and Planning (Animal Health) Eligible cost: 50%, up to a maximum of \$5,000
- Education, Training, Assessment and Planning (Plant Health) Eligible cost: 50%, up to a maximum of \$5,000

Enhancing Plant Health

Eligible Activities:

- Technologies and Processes to Reduce Plant Pest Contamination and Risk Eligible cost: 35%, up to a maximum of \$100,000

Food Safety for Your Business

Eligible Activities:

- Food Safety and Traceability System Improvements Eligible cost: 50%, up to a maximum of \$75,000
- Traceability Equipment (Food Safety) Eligible cost: 35%, up to a maximum of \$10,000
- Food Safety Equipment Eligible cost: 35%, up to a maximum of \$10,000
- Food Safety and Traceability Training Eligible cost: 45%, up to a maximum of \$1,500
- Food Safety and Traceability Gap Assessment and Pre-audit Eligible cost: 45%, up to a maximum of \$3,000

Improving Productivity

Eligible Activities:

- Labour Productivity Plans Eligible cost: 50%, up to a maximum of \$25,000
- Technology and Equipment to Improve Labour Productivity Eligible cost: 25%, up to a maximum of \$200,000

- Input Efficiency and Waste Reduction Eligible cost: 25%, up to a maximum of \$75,000
- Enterprise Resource Planning and Supply Chain Management Systems Eligible cost: 35%, up to a maximum of \$100,000

Southwestern Ontario Development Fund (SWODF)

Eligibility Criteria

The fund supports projects and investments to businesses, municipalities and not-for-profit organizations for economic development in southwestern Ontario. Southwestern Ontario includes the following 18 geographic areas: Brant; Bruce; Chatham-Kent; Dufferin; Elgin; Essex; Grey; Haldimand; Huron; Lambton; Middlesex; Niagara; Norfolk; Oxford; Perth; Simcoe; Waterloo; Wellington.

Business Projects Eligibility

To be eligible, businesses need to:

- Invest at least \$500,000 in their project (or \$200,000 if you are in rural Ontario)
- Employ at least 10 people (or 5 if you are in rural Ontario)
- Commit to creating at least 5 new jobs (or 30% increase for companies with fewer than 15 employees)
- Be able to provide 3 years of operations/financial statements
- Be located in, or plan to locate in, a community in southwestern Ontario

Community Economic Development Projects Eligibility

To be eligible, projects need to:

- Be led by municipalities, economic development organizations (including sector groups) or consortia
- Focus on economic and business development and job creation in the community or region by investing in infrastructure or implementing strategies to advance regional economic development priorities

Career Ready Fund's Auto Stream 2019-20 **Eligibility Criteria**



<u>CanExport Innovation (formerly Going Global Innovation)</u> Eligibility Criteria

- Be registered in Canada;
- Be an Innovator from one of the following Canadian organization types based in Canada:
- Small or Medium-sized Enterprises (SMEs);
- Academic institutions; and
- Non-government research centres.
- Have decision making authority over the technology.
- Have confirmed interest from a potential foreign collaborator they know who you are, they know what your technology is AND they want to meet with you.
- Will be in a position to launch your technology into the global marketplace within the next 1-5 years.
- Own or co-own the intellectual property (IP) or the technology that will be commercialized;
- Demonstrate adequate managerial capabilities to execute the proposed activities and meet CanExport Innovation Recipient requirements;
- Have sufficient financial resources generated from private sources to cover their share of proposed CanExport Innovation activities;
- Not be funded entirely by Canadian government organizations (federal, provincial, territorial, municipal or Crown corporations);
- Be one of the parties performing the R&D work resulting from the Contractual Agreement(s);
- Demonstrate clear benefit to the Canadian economy should the proposed project be successful; and
- Applicants who have previously been approved and completed a CanExport Innovation Project must not have any outstanding documents still remaining to be submitted to CanExport Innovation. All reporting requirements for previous projects must be fulfilled in order to be considered for current CanExport Innovation funding.

Eligible Cost

- For activities requiring travel, CanExport Innovation determines the eligibility of travel expenses based on the following criteria:
 - Travel duration: Reasonable travel duration is determined based on the scope and complexity of the R&D collaboration. In general, a maximum of four days travel is supported. Exceptions may be approved with sufficient justification. For destinations that involve long overnight flights or which exceed five time zones, the CanExport Innovation travelers may arrive one full day prior to meetings.



- Number of participants: Only the travel costs of participants deemed as essential to formalizing the collaboration will be considered for CanExport Innovation funding. Travel expenses for individuals who are assessed as non-essential to the formalization of the R&D collaboration will not be funded.
- Costs: Funding of costs is allocated on a per person and or per date rate. Request for funding are assessed based on reasonability of estimated costs provided in the application submission. For certain expenses, reasonability of estimated costs is assessed against established CanExport Innovation guidelines. Those guidelines are detailed below in the description of each type of expenditure.
- Eligible expenditures are funded on a cost-sharing basis with CanExport Innovation supporting up to a maximum of 75 percent of the eligible expense type.
- Requested funding for eligible expenditures may be adjusted upon assessment based on current CanExport Innovation policies.
- Economy class airfare: Only the cost of lowest return economy class airfare for the straight route is eligible. For CanExport Innovation purposes, the straight route is defined as the route between the traveler's home location and the location of the approved CanExport Innovation activities, without any additional stops/legs/destinations for non-CanExport Innovation related purposes. For trips that include multiple activities and destinations that require additional air travel, only the cost of a multi-city lowest economy class airfare rate is eligible. A multi-city airfare rate must represent the travel route starting from the traveler's home location to the first approved location, travel route between the approved locations, and the travel route from the last approved location back to the traveler's home location.
- Accommodations: In determining reasonable accommodation rates, as a guide CanExport Innovation uses the Public Works and Government Services of Canada Accommodation Rates. Hospitality is ineligible for CanExport Innovation reimbursement and must not be included in accommodation estimates.
- Meals: CanExport Innovation allows for a daily per diem limit of CAD\$100 per day to cover the cost of meals on the dates of travel to the location of the approved CanExport Innovation activity; dates of the meetings and/or site visits; and the dates of travel back to the Applicant's home location.
- Local transportation: Reasonable local transportation in Canada and the foreign country, such as taxis, car rentals, public transportation, train in market, etc., are eligible expenses. All local transportation costs must be for the following purposes:
- To and from airports;
- To and from meetings; and,
- To and from site visits.
- Legal fees: CanExport Innovation may provide a maximum of \$1,000 in CanExport Innovation funding (e.g. 75% of \$1,333 in legal fees) towards legal services to develop instruments necessary to formalize a contractual agreement for the R&D collaboration.

Only in exceptional circumstances will CanExport Innovation support registration fees for a conference. - Audio/visual equipment rental: CanExport Innovation provides support for reasonable audio/visual equipment rental costs. Audio/visual equipment rental expenditures covered under Meeting room rentals are not eligible as separate expenses. CanExport Innovation will consult with locally engaged staff to determine reasonability of estimated costs. Applicant may provide a quote outlining the audio/visual equipment rental costs as evidence of estimated costs.
- Visas: Only expenses for single entry visas are eligible.



Scientific Research & Experimental Development (SR&ED) Tax Credit.

SR&ED is a tax incentive program that encourages Canadian businesses to participate in research and/or experimental development.

<u>Customs Duty Drawback.</u> If you pay duties on source materials or components that you later export in the original or modified form, you may qualify for a refund of customs duties paid at the time of import.

Factoring. This type of financing helps you free up capital that is stuck in unpaid debts and transfers the default risk associated with the collection to a factoring company.

<u>Capital Lease</u>. A capital lease is a contract entitling a renter to a temporary use of an asset (such as equipment). The capital lease requires a renter to add assets and liabilities associated with the lease if the rental contract meets specific requirements.

Asset-Based Lending. Asset-based lending is a business loan secured by collateral (assets). The loan, or line of credit, is secured by inventory, accounts receivable and/or other balance-sheet assets.
